2: Hazardous Identification

Classified as hazardous according to the Globally Harmonised System of Classification and Labelling of Chemicals (GHS) criteria of Safe Work Australia and classified as a non-dangerous good according to Australian Dangerous Goods Code.

Spills and Disposal Small Spills

Mop or wipe up with a rag or paper towel and dispose of in the rubbish. Wash down

Large Spills

Contain, collect and recycle spilt product if possible otherwise absorb spill with material such as soil, sand, attapulgite, vermiculite. Collect and seal in properly labelled, chemical resistant containers. Wash area with water. Seek disposal options by a licensed waste contractor.

11: Toxicological Information

Ingestion Product is considered to be of low toxicity. Ingestion of large amounts may cause irritation

to the oesophagus and cause gastrointestinal upset. The oral LD₅₀ for

Didecyldimethylammonium chloride in rats is reported to be greater than 5000 mg/kg.

Eye Eye contact will cause stinging, blurred vision, tearing and redness.

Skin Prolonged skin contact causes redness, itching, irritation or dermatitis.

Inhalation May cause irritation to the mucous membrane and upper airways, especially where vapours

or mists are generated. Symptoms include sneezing, coughing, wheezing, shortness of

breath, headache and dizziness.

Ecotoxicity The LC₅₀ (median lethal concentration) for fish is 0.42-1.9 mg/L, for aquatic invertebrates is

0.76-2.2 mg/L and for algae is 0.23-2.9 mg/L.
